# School District Trustees Must Reside in Trustee Area (TRA)

**QUALIFICATIONS FOR SCHOOL DISTRICT GOVERNING BOARD MEMBERS:** Any person, who is a resident of the school district, a registered voter, and who is not disqualified by the Constitution or laws of the state from holding a civil office, is eligible to be elected or appointed a member of a governing board of a school district without further qualifications.

**QUALIFICATIONS FOR COUNTY BOARD OF EDUCATION MEMBERS:** Any registered voter is eligible to be a member of the County Board of Education except the County Superintendent of Schools, any member of his or her staff, or any employee of a school district. Each member of the board shall be an elector of the trustee area which he or she represents and shall be elected by the electors of the trustee area. Education Code §§ 1000, 1006(a).

**QUALIFICATIONS FOR UTILITY DISTRICT DIRECTORS**: Candidates for the above listed Utility Districts must first obtain qualified signatures on Nomination Papers in accordance with Public Utility Code 11828(b) to qualify; candidates must be a registered voter residing within the District (or Ward) for which he or she is a candidate. Candidates are elected at large within the entire District.

**NOTICE IS FURTHER GIVEN** that official declarations of candidacy for eligible candidates desiring to file for any of the above elective offices may be obtained from the office of the County Clerk/Registrar of Voters located in the Annex behind the Historical Courthouse at 220 South Lassen Street, Susanville, CA, 96130, on or after July 15, 2024, and must be filed not later than 5:00 p.m. on August 9, 2024; provided, if declarations of candidacy for an incumbent are not filed by the latter date and hour, eligible candidates, other than the incumbent for such office, shall have until 5:00 p.m. on August 14, 2024, to file declarations of candidacy.

Appointments to each elective office will be made by the supervising authority as prescribed in Section 10515, California Elections Code, in the event there are no candidates, or an insufficient number of candidates for such office and a petition for an election is not filed with the elections official within the time period prescribed by Section 10515 Elections Code, that is by 5:00 p.m. on August 14, 2024.

**NOTICE IS FURTHER GIVEN** that all active registered voters will automatically be mailed a Vote-by-Mail ballot package beginning on Monday, October 7, 2024.
