ACTION REQUESTED: Appoint nominees, in lieu of Election as per Section 10515 of the California Elections Code and Section 5326 of the Education Code.

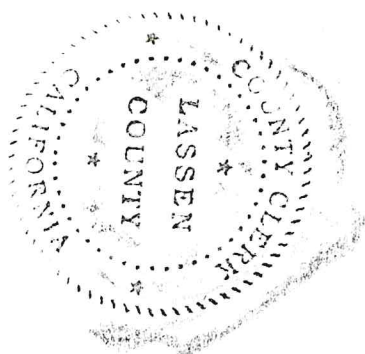

By 5:00 p.m. on the 83rd day prior to the November 5, 2024, General Election, the number of candidates for the office of Director/Trustee did not exceed the number of offices to be filled at said election, or only one person filed a Declaration of Candidacy for any such office, or no one filed a declaration of candidacy for such office and no petition signed by 10 percent of the voters or 50 voters (whichever is the smaller) in any of the listed districts was presented to me, as the officer conducting the election, requesting that the Statewide General Election be held in such district.

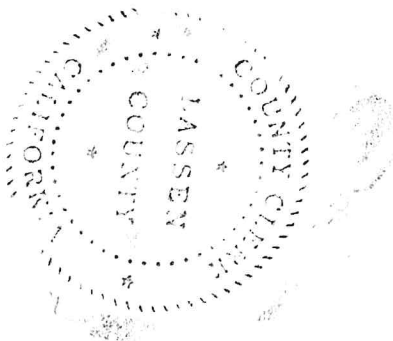
I, JULIE BUSTAMANTE, County Clerk of the County of Lassen, State of California, certify pursuant to the authority of Section 5326 of the **Education Code**, as follows:

If, by 5:00 p.m. on the 83rd day prior to the November 5, 2024, General Election, the date fixed for the governing board election, only one person has been nominated for any elective office to be filled at that election, or no one has been nominated for the office, or in the case of members to be elected from the district at large, the number of candidates for governing board member at large did not exceed the number of offices to be filled at that election, or in the case of members to be nominated by trustee area and elected at large, the number of candidates did not exceed the number required to be elected governing board member at large nominated by that trustee area, or in the case of members to be elected at large in accordance with Sections 5030.5, 5030.6, and 5030.7, no more than one person has been nominated for each membership position, and a petition signed by 10 percent of the voters or 50 voters (whichever is the smaller number).

In accordance with Section 5328 of the Education Code, if pursuant to Section 5326 a district election is not held, the qualified person or persons nominated shall be seated at the organizational meeting of the board, or if no person has been nominated or if an insufficient number is nominated, the governing board shall appoint a qualified person or persons, as the case may be, at a meeting prior to the day fixed for the election, and such appointee or appointees shall be seated at the organizational meeting of the board as if elected at a district election.

The affected districts, and persons nominated to uncontested offices are set forth on the attached.
